8. Nova Scotia Offshore Wind Development Assessment Committee Presentation:

The Offshore Wind Development Assessment Committee presented to Council. Presentation highlights included:

- Their purpose is to determine suitable locations in Nova Scotia for offshore wind development.
- Multiple fisheries and socioeconomic impact assessments will take place over the next 18 months before any development can take place.
- The Committee is consulting with different Mi'kmaw knowledge keepers and organizations such as MKK, CMM, and each of the 13 Band Councils over the next two months.
- There are open seats on their Indigenous Advisory Committee and are seeking suggestions on people to appoint.
- The Committee will be invited to set up at the monthly community engagement sessions in Sipekne'katik once dates are established.
